- Mann (2013) argues that the increase in so called democracies may result in an "erosion of civil liberties." These new "democracies" often have emerged from former colonies.

METHODS



The quality of government dataset from the University of Gothenburg was used.



Analyses used Pooled Time Series regression and Ordinary Least Square regression.



The **Empowerment Index** is predicted by previous Colonization, Polity, and GDP/capita.

FINDINGS


Wealthier

Democratic countries are more likely to support Empowerment Rights.


Nation's colonial pasts affect current Empowerment Rights.

Empowerment Index, GDP/c & Polity


Higher levels of GDP/c and Polity help promote Empowerment Rights.




Empowerment by GDP/c (logged)

Former Italian colonies have worse Empowerment Rights than the never colonized countries, former Portuguese colonies have better Empowerment Rights.

CONCLUSION



National wealth (GDP per capita) helps promote **Empowerment Rights.**



Democratic nations tend to promote empowerment rights more than non-democratic nations.



Some countries previously colonized by Portugal have better empowerment scores, however some former Italian colonies have lower empowerment scores.
